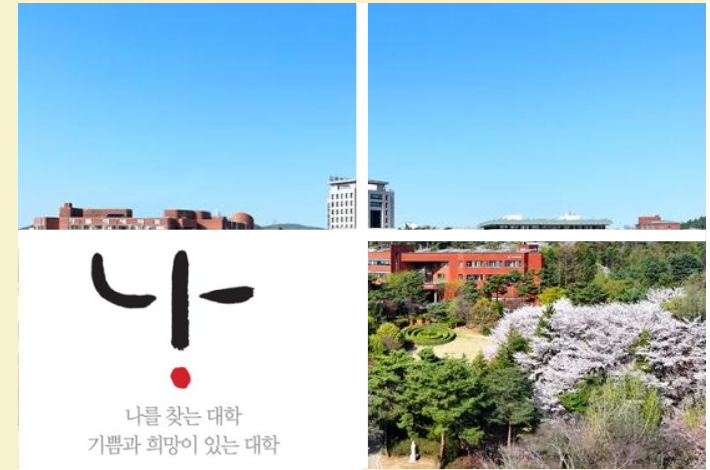

Korean Language Program

6steps
Curriculum

There are **6 levels** of the course, so students can choose the course that suits their levels. By the end of Level 4, students will be able to communicate in Korean w/o difficulty in everyday life, and by the end of Level 6, they will be able to speak Korean fluently.

Students are taught by **Excellent Faculties** who specialize in teaching Korean. Level 1 and 2 students are taught with **OK KOREAN**, a textbook developed by the KLI of CUK.

Submission of Documents (for D-4 Visa)



1. Application Form

2. Passport
(Copy)

Check passport expiration date

3. Graduation certificate
(Original)

Proof of academic qualification must be verified by the Korean Consulate or through the Apostille.

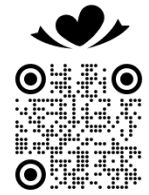
- High school graduate : Graduation certificate
- University student : High school graduation certificate + University enrollment certificate
- University graduate : University graduation certificate
- China : With the Chinese Ministry of Education's operating education, Certificate issued by degree certification center only (www.chsi.com.cn)

4. Bank balance certificate
(Original)

Proof of bank deposit balance worth USD 10,000 (in the name of the applicant or parent)

Must be issued within 30 days from the date of submission

Submission of Documents (for D-4 Visa)

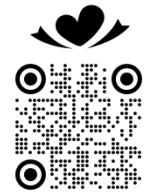


- 5. Family relationship certificate (Original) Must be verified by the Korean Consulate or Apostille verified.
- 6. Insurance (Copy) Submit before entry
* To be announced seperately
- 7. TOPIK score report Applied only for those who have the grades

- When submitting original documents, only original (or notarized) documents from schools, banks, or government offices are acceptable.
- Submitted documents and application fees are non-refundable

※ If you don't need to apply for a D-4 Visa, you need to submit

1. Application form
2. Passport (Copy, check expiration date)
3. Graduation certificate (Copy)



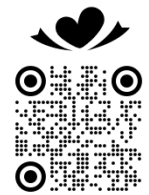
Notes for Visa and residency

- ✓ If you require a student visa (D-4), you must register for at least 6 months to comply with the Ministry of Justice's residence guidelines.
- ✓ Notice from the Minister of Justice : For those who are required 4 semesters enrollment, please check your requirements in advance.
 - 1) 21 countries notified by the Minister of Justice: Family relationship certificate is required

Ghana, Nigeria, Nepal, Myanmar, Bangladesh, Vietnam, Mongolia, Sri Lanka, Uzbekistan, Ukraine, Iran, Egypt, India, Indonesia, China, Kazakhstan, Kyrgyzstan, Thailand, Pakistan, Peru, Philippines
 - 2) 4 semesters (1 year) enrollment required countries: 4 semesters tuition payment are required

African countries, Ukraine, Nepal, East Timor, Laos, Mongolia, Myanmar, Bangladesh, Vietnam, Bhutan, Sri Lanka, Uzbekistan, India, Kazakhstan, Cambodia, Kyrgyzstan, Tajikistan, Turkmenistan, Pakistan, Philippines, Syria, Afghanistan, Yemen, Oman, Iraq, Iran, Palestine
- ✓ We may ask you to provide additional documentation based on Ministry of Justice's policy and guidance
- ✓ Applicants previously denied a Visa must notify KLI of that fact. If the applicant's visa is not issued because of their prior record, their enrollment may be rejected.

Tuition Fee

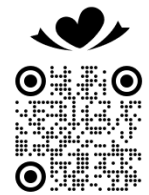


- 1. Application Fee 60,000KRW
- 2. Tuition Fee per semester 1,450,000KRW (10weeks)

3. Discounts

| Description | Discount rate | Tuition Fee per semester |
|---|---------------|--------------------------|
| 1 year discount (4,930,000KRW per year) | 15% | 1,232,500KRW |
| The Catholic University undergraduate / graduate students / exchange students | 30% | 1,015,000KRW |
| Catholic clergy (priests and nuns) | 50% | 725,000KRW |

- Refund criteria : Tuition fees excluding the application fee can be fully refunded before the start of the semester. Refunds after the start of the semester vary depending on the duration of the course (No refunds after more than 50% of the course period has been completed).



Insurance

- ✓ Students entering the Korean Language Program (D-4-1) must purchase insurance locally and email a copy of the policy before their arrival to Korea.
- ✓ The insurance covers medical treatment while studying in Korea and the period of insurance must cover at least 6 months.
- ✓ You must submit a notarized copy of your insurance policy translated either in Korean or English. It should include detailed collaterals too.
- ✓ Insurance helps to protect you against unfortunate events that may occur while you are studying abroad. All newly enrolled students are required to have insurance as there might be disadvantages if you don't have it.
